## CAMPAIGN FOR CHANGE

On Friday, July 11, Barack Obama's Campaign for Change (CFC) arrived in Western Wisconsin at the Office at 522 Second St., Hudson. Over 100 people heard talks given by special guest Margaret Anderson-Kelliher, Speaker of the Minnesota House of Representatives. Local candidates for Wisconsin Assembly and Senate were also on hand to greet the visitors.

Phil Walzak, Communications Director for the CFC gave interviews to Channels 5, 9 and 11 which had camera crews on hand for the Grand Opening. The Star Observer was on hand with both a photographer and a reporter. This was great publicity considering that John McCain was in Hudson for a Town Hall meeting.

The CFC in Hudson is housed in a 1200 sq. ft. office which is now up and running with high speed internet service, several computers for internet access, several PCs for use during the campaign, and wireless access for use with the laptop computers which the staffers and volunteers use for every aspect of the campaign process.

Tanya Bjork, statewide General Election Director of the CFC recently announced that there are already more than 60 staffers on the ground in the state. Nine offices (including Hudson) are already open, with thirteen more in the final stages of gearing up. Tanya also mentioned that there are at least six more locations being considered for campaign locations.

The Hudson CFC staff has access to thousands of individuals who have already made contact with the Obama campaign. They have email addresses and phone numbers to contact these individuals.
